

# 2026 Fee Schedule and Further Information

## International Students

This Fee Schedule and Further Information must be read in conjunction with the Enrolment Terms and Conditions. Please update Parent(s) and Student(s) information (including contact details and medical information) on Consent2Go. All amounts in this document are quoted in Australian Dollars.

### English Language Intensive Course for Overseas Students (ELICOS)

As set out in Carey's Enrolment Terms & Conditions, Carey may require International Students to complete an ELICOS as a condition of entry. If the Student does not make satisfactory progress, then in accordance with clause 4.4 the offer of enrolment will lapse.

In the event that a student has not made satisfactory progress at their ELICOS and the offer of enrolment lapses, any School Fees already paid to Carey may be refunded in accordance with the Enrolment Terms & Conditions.

If students are delayed arriving in Melbourne to begin their English language course, they are required to notify Carey as soon as possible as failure to make adequate progress in the course or attend the entire course may result in the offer of enrolment lapsing.

### Educational Services for Overseas Students Framework (ESOS)

Carey's International Student program is governed by the ESOS Framework, which includes:

- the Education Services for Overseas Students Act 2000 (the ESOS Act)
- the ESOS Act 2000 Regulations
- the Educational Services of Overseas Students Act (Registration Charges) 1997 (the ESOS Charges Act)
- the National Code of Practice for Registration Authorities and Providers of Education and Training to Overseas Students (the National Code).

### International Student Health Cover

All international students are required to hold Overseas Student Health Cover for the duration of their visa. Carey arranges such cover before the students commence their ELICOS.

Estimated cost is listed in the Other Costs table below.

### Personal Spending

Students find that approximately \$AUD50–\$AUD100 per week covers their spending needs for entertainment, transport and personal needs. This varies for each individual.

### Application Fees

An Application Fee of \$AUD200 is payable for each student's enrolment application at Carey. This fee is non-refundable and non-transferable. Applications can be made online at [carey.com.au](http://carey.com.au) or contact the Admissions Office on +61 3 9816 1242.

### Enrolment Fees

Following an offer of enrolment an Enrolment Fee of \$AUD1,800 is payable to confirm the enrolment. This fee is non-refundable and non-transferable.

### Tuition Deposit

To accept an offer of enrolment, Parent(s) must pay a tuition deposit equivalent to half a year's Tuition Fees.

If the student is withdrawn or does not commence at Carey in that year, refunds of tuition deposits will be handled in accordance with clause 19 of the Enrolment Terms & Conditions.

### Insurance

Vehicles parked in the School carpark, and personal items brought onto the School's campuses are not covered by Carey insurance. Please ensure musical instruments and items of value are separately insured.

Student accident insurance is available for accidents which occur to students Australia wide. Please email [accounts.office@carey.com.au](mailto:accounts.office@carey.com.au) if you require a claim form.

Student travel insurance is included in school fees for all school organised national and international excursions, camps and trips more than 100km away from the Kew campus. Please email [accounts.office@carey.com.au](mailto:accounts.office@carey.com.au) if you require a copy of the Product Disclosure Statement (PDS) or a claim form.

### Student Temporary Leave of Absence

Where a period of temporary leave between four weeks to one year is required please apply to your Head of School.

### Withdrawal of a Student

As per your signed Enrolment Agreement, Parents must provide one term's written notice to the Admissions Office of the permanent withdrawal of a student. If the required notice is not received, a fee equivalent to one half of a term's fee is payable.

<sup>1</sup> Consolidated Fees cover Technology fees, Experiential Learning, Outdoor Education programs and specific activities and resources applicable to each year level. This fee does not include individual elective trips or additional extras.

<sup>2</sup> A School-provided iPad is compulsory for all Prep to Year 3 students. A School-provided laptop is compulsory for all year levels from Year 4 to Year 12. Further information can be obtained from CareyLink.

<sup>3</sup> The compulsory State Tax and Surcharges levy will be included separately on each account.

<sup>4</sup> International Student fees are billed twice per year. This amount includes Tuition Fee and State Tax and Surcharges. Consolidated Fee, Consolidated Fee (taxable supply) and Digital Device Rental are billed annually in April each year.

Additional/Optional Fees

Additional/Optional Fees will depend on a student's involvement beyond the standard educational program. For example, additional music tuition, participation in rowing, selective trips and camps, sport jumpers, unreturned library books etc. Information about these fees will be provided to Parents as part of the consent process for these events. Billing Dates

Tuition Fees are billed in two equal instalments as follows:

- Tuition fees and State Tax and Surcharges are billed in advance of tuition, in the October 2025 and April 2026 accounts.
- Consolidated Fees and Digital Device rental charges are billed for the year in the April 2026 account.

### Late Fees

Due dates are specified above, noted on each invoice, and in the School calendar. Fees not paid by each due date will incur a late fee of \$AUD125, which is not reversible. The School will not be responsible for any delays in receiving your payment (including banking delays). As per the Enrolment Terms and Conditions, Carey may take reasonable steps to recover unpaid fees, including but not limited to, legal action.

### Payment Plans

### Carey Homestay Program

Carey offers a homestay program for International Students who are in Australia unaccompanied. International Students participating in the homestay program must live in homestay accommodation approved by Carey for the duration of their enrolment.

If participating in the Homestay Program, Carey will charge a Homestay administration fee of \$500 and administers the Homestay Bond, equivalent to four (4) weeks' Homestay Fees.

Payment arrangements for the Homestay Program are arranged between the Homestay Host and the International Student's parents.

### Local Support Person

As set out in the Enrolment Terms & Conditions, all International Students participating in the Homestay Program must have a Local Support Person at all times while enrolled at Carey.

Families may engage Carey's preferred provider, International Student Advocates (ISA), to provide a Local Support Person. Estimated costs are listed in Other Costs above.
